## Nomination Form: General Council Election 2017-18

### Corporate Representative

#### Information for Corporate Members

Corporate Members of the History Council of NSW (HCNSW) may nominate up to two representatives. Separate nomination forms should be used for each nomination.

#### The General Council

The election of the members to the General Council is set out in the Objects and Rules of the organisation. The General Council is elected bi-annually by the HCNSW's membership. The General Council is comprised of 20 members; 15 are elected by the corporate membership, three by the individual membership, and two by the Indigenous membership.

#### The Election

The election for the 2017 - 2018 General Council is by nomination followed by a ballot vote at the Annual General Council Meeting. The call for nominations will take place from Monday 20 January 2017 to Monday 20 February 2017. Voting will take place on Friday 24 February 2017 at the Annual General Council Meeting. If the same number of nominations are received as there are positions, a vote will not be held.

#### Announcement of Election Results

The election results will be announced at the Annual General Meeting 2017. This meeting will be taking place on Friday 24 February 2017 at 5:30-6:30pm at History House, 133 Macquarie Street, Sydney.

#### Nominations by Corporate Members

According to the HCNSW's Objects and Rules only financial members of the Council can make nominations, vote or hold office. Nominees, seconders and proposers must be financial members of the Council for the year 2017.

- email confirmations will be accepted in lieu of written or electronic signatures;
- must include the written consent of the candidate who is a member of the HCNSW.
