

**Nomination Form: General Council Election 2019 & 2020****Corporate Representative****Information for Corporate Members**

Under Clause 18.2 (b) of the [Constitution of the History Council of NSW](#) (HCNSW) Corporate Members of the HCNSW may nominate up to two representatives. **Separate nomination forms should be used for each nomination.**

**The General Council**

The election of the members to the General Council is set out in the Objects and Rules of the organisation. The General Council is elected bi-annually by the HCNSW's membership. The General Council is comprised of 10 members, 10 of whom will be elected by the corporate and individual membership with priority given to indigenous members and representatives of Aboriginal organisations members of the association.

**The Election**

The election for the 2019 & 2020 (2 years, inclusive) General Council is by nomination followed by a ballot vote at the Annual General Council Meeting. The call for nominations will take place from Monday 8 April 2019 - Friday 26 April 2019. Voting will take place on Tuesday, 7 May 2019 at the Annual General Council Meeting. If the same number of nominations are received as there are positions, a vote will not be held.

**Announcement of Election Results**

The election results will be announced at the Annual General Meeting 2019. This meeting will be taking place on Tuesday, 7 May 2019 at 5:30-7:30pm at the Don Bank Museum, 6 Napier Street, North Sydney.

**Nominations by Corporate Members**

According to the HCNSW's Objects and Rules only financial members of the Council can make nominations, vote or hold office. Nominees, seconders and proposers must be financial members of the Council for the year 2019 .

**Nominations**

- must be signed by a proposer and seconder who are members of the HCNSW;
- must include the written consent of the candidate who is a member of the HCNSW;
